PRIVACY POLICY (GENERAL DATA PROTECTION REGULATION – ART: 13-14 of the GDPR)

TStat S.r.l, with registered offices in via Rettangolo, 12/14 Sulmona (AQ) Italy - tel. 0864 210101 – mail: <u>tstat@tstat.it</u> – PEC: <u>tstat@tstat.ticertifica.it</u>, recognises the importance of maintaining the confidentiality, integrity and security of your personal data ("*Personal Data*") and hereby inform you that any *Personal Data* which you provide to TStat S.r.l. either through our Websites (<u>www.tstat.it</u>, <u>www.tstat.eu</u> and <u>tstattraining.eu</u>) or any personal or company data which you may provide directly to us, will be processed in compliance with the current European Union privacy laws (Regulation (EU) 2016/679 – "GPDR") and with any special local regulations application from time to time for the processing of data outside the European Union.

This Privacy Policy Statement ("*Privacy Policy*") describes the ways TStat S.r.l. ("our Company") collects information from and about you, and what we at TStat do with the information, so that you may decide whether or not to provide information to us. By accessing our website or purchasing our products or services you agree to this Privacy Policy in addition to any other agreements we might have with you. In the event of such agreements contain terms that conflict with this Privacy Policy, the terms of those agreements will prevail. This Privacy Policy does not govern the practices of entities that our Company does not own or control, or entities that do not own or control our company or people that our Company does not employ or manage.

1. Collection of your Personal Information

The information we collect may include your name (first and last name), position, address, email address, phone number, tax registration number, goods or services transaction information, preferences you submit and preferences that are generated based on the data you submit, number of clicks, messages, communications, postings, log-ins (if you are in possession of a technical support account on one of our Websites), network activity, product and service selections and other things that identify you. We collect personal information from you at several different points, including, but not limited to the following:

- when we correspond with you as a customer or prospective customer;
- when you visit our website;
- when you register as an end-user of our services via one of our websites;
- when you contact us for help;
- when you attend our customer conferences, courses or webinars; and
- when the site sends us error reports or application analytics data.

2. Our Company Use of your Personal Information

TStat S.r.l. may use information that we collect about you to:

- conclude any commercial contracts relating to the purchase of our goods and services;
- manage your customer relationship and provide you with customer support;
- help improve our products and services and customize user experience;
- perform research and analysis about your use of, or interest in, our products, services, or content, or products, services or content offered by others;



- communicate with you by e-mail, postal mail, telephone and/or mobile devices about our products or services that may be of interest to you;
- develop and display content and advertising tailored to your interests on our site and other websites;
- enforce our terms and conditions;
- manage our business; and
- perform functions as otherwise described to you at the time of collection.

3. Data Processing Methods

Your Personal Data will be processed by suitable electronic or automated means and computerised tools, or manually and on hard copy, exclusively for the purposes for which they have been collected and guaranteeing the security and confidentiality of any processed information. Your Personal Data will be processed only by TStat S.r.l. and subsidiaries or internal staff duly authorised to do so under their respective job duties. Your personal data may also be processed by third parties to the extent necessary and/or instrumental for the above purposes. These third parties will act on behalf of TStat S.r.l. as data processors (e.g. service providers, carriers, IT technicians or any other suppliers appointed by TStat S.r.l. to carry out and/or manage any promotional campaigns for TStat's products and services, etc.).

4. Our Transfer and Disclosure of your Personal Information to Third Parties

Our Company may use information that we collect about you with third parties ONLY in the ways that are described in this Privacy Policy:

- we may provide your information to our sub-processors (for example course leaders) who perform functions on our behalf;
- third party contractors may have access to our databases. These contractors do however, sign a standard confidentiality agreement with TStat S.r.l.;
- we may share your data with any parent company, subsidiaries, joint ventures, other entities under a common control or third-party acquirers. We expect these other entities will honour this Privacy Policy;
- we may allow a potential acquirer or merger partner to review our databases, although we would restrict their use and disclosure of this data during the diligence phase;
- as required by law enforcement, government officials, or other third parties pursuant to a subpoena, court
 order, or other legal process or requirement applicable to our Company; or when we believe, in our sole
 discretion, that the disclosure of personal information is necessary to prevent physical harm or financial loss,
 to report suspected illegal activity or to investigate violations of our agreements or Company policies;
- we may share your information with third parties (for example, the software producers we represent (necessary to allow them to issue you with a software licence)) with your consent or direction to do so. Please note that these third parties may be in countries outside the EU, where the laws on processing personal information may be less stringent than in your country. We reserve the right to use, disclose and transfer non-personal information to our partners, advertisers and other third parties at our discretion.

Your Personal Data will not be used for third-party advertising purposes or for the promotion of products, services or initiatives by entities other than the TStat Group, nor shall they be disclosed to unknown persons under any circumstances.

5. The Security Measures Taken to Protect your Personal Information

TStat S.r.l. uses industry-standard technologies when transferring and receiving data exchanged between our Company and other companies to help ensure its security. Our internet sites have security measures in place to help protect information under our control from the risk of accidental or unlawful destruction or accidental loss, alteration or unauthorized disclosure or access. However, "perfect security" does not exist on the Internet. Moreover, if our

6. TStat S.r.l's Use of Cookies, Web Beacons, Web Analytics Services, and Links

Since this website does not control the privacy policies of third parties, you are subject to the privacy practices of that third party. We encourage you to ask questions before you disclose any personal information to others;

8. Legal Basis for Processing your Personal data (EEA and Switzerland only)

With respect to personal data collected from individuals from the European Economic Area or Switzerland, our legal basis for collecting and using the personal data will depend on the personal data concerned and the specific context in which we collect it. 9. Limiting Use, Disclosure, Retention

TStat S.r.l. identifies the purposes for which the information is being collected before or at the time of collection. Your personal data will be processed and stored for as long as required for the purposes for which they were collected, and in accordance with the storage periods provided for by the applicable laws, or until you revoke your consent to the processing, if applicable. Unless you consent or we are required by law, we will only use the personal data for the purposes for which it was collected. If TStat will be processing your personal data for another purpose later on, we will seek your further legal permission or consent; except where the other purpose is compatible with the original purpose. We will keep your personal data only as long as required to serve those purposes. We will also retain and use your personal data for as long as necessary to comply with our legal obligations, resolve disputes, and enforce our agreements. After such period, your Personal Data will be automatically and permanently erased or made anonymous.

10. International Transfers of your Personal data

Your personal data subject to Processing may be transferred abroad, within and/or outside the European Union, always in compliance with the rights and guarantees provided by the applicable legislation.



In connection with its activity as an international software distributor, TStat S.r.l. may transfer your data outside the EEA, depending on where the headquarters of the software manufacturer we are representing in our contacts with you are located. According to the terms and conditions of use of the parent software company which we represent, software licences are considered nominative, released in the name of the end user, even though ultimate ownership rights always remains with the entity purchasing the licence. For this reason, TStat S.r.l. is obliged to provide the parent company with the following information regarding the licence end user: i) name and address in the case of a acquisition for private use; ii) end user name, organisation and address of the organisation in the case of company or institutional acquisitions. Without this information, the parent company is unfortunately unable to create the required licence.

TStat S.r.l. is an international official software distributor for a number of countries situated both within and outside the European Economic Area. Information collected by our company is stored and processed in the European Economic Area (in electronic form on our Microsoft Italia Cloud Account and were required for administrative or legal purposes) in printed format at our Head Office. It may however, be accessed/transferred or held in any other country in which our Company or agents or contractors maintain facilities. By accessing our sites and using our services, you consent to any such transfer of information outside of your country. Such countries may have laws which are different, and potentially not as protective, as the laws of your own country. Whenever we share personal data originating in the European Economic Area or Switzerland we will rely on lawful measures to transfer that data, such as EU standard contractual clauses. If you reside in the EEA or other regions with laws governing data collection and use, please note that you are agreeing to the transfer (when necessary to conclude any commercial contracts relating to the purchase of our goods and services) of your personal data to the United States or other jurisdictions in which we, or the Software House which we represent, operate. By providing your personal data, you consent to any transfer and processing in accordance with this Policy.

11. Accuracy of Personal data

We do our best to ensure that the personal data we hold and use is accurate. We rely on the customers we do business with to disclose to us all relevant information and to inform us of any changes.

12. Your Access to and Updating of your Personal Data

Reasonable access to your personal data may be provided upon request made to our Company at the contact information provided below. If access cannot be provided within that time frame, our Company will provide the requesting party a date when the information will be provided. If for some reason access is denied, we will provide an explanation as to why access has been denied. We reserve the right to charge a reasonable fee in advance for copying and sending the information requested.

If you would like us to delete any personal data held about you, we will do so on request unless we need to hold the information as part of the provision of products and services to you.

13. Marketing Communications

We offer those who provide personal contact information a means to choose how we use the information provided. You may manage your receipt of marketing and non- transactional communications by clicking on the "unsubscribe" link located on the bottom of our marketing emails.

14. Additional Rights (EEA and Switzerland only)

If you reside in the European Economic Area or Switzerland, You may exercise the additional rights under Articles 15 to 21 GDPR, and specifically the right to request information as to whether your Personal Data is being processed and as to the characteristics of the processing, the right to rectification and erasure of your Personal Data, the right to

object to the processing and/or the right to have those Personal Data transmitted to another controller. More specifically:

- **Right of erasure**. You may have a broader right to erasure of personal data that we hold about you.
